

## Standing Together's Criminal Justice Innovation

STADV established operational working groups in relation to criminal justice work in its earliest activities, creating and establishing referral pathways for survivors reporting to the Police from as far back as 1998.

Since this time, STADV and partners have created the SDVCs but have also led practice in relation to police training, establishing referral pathways to support for Independent Domestic Violence Advisors (IDVAs) and early multi-agency case conferencing in relation to criminal justice cases which developed into the Multi-Agency Risk Assessment Conference (MARAC).

STADV were part of the review with the Government Team (CPS, Home Office, MoJ) to review the first 25 SDVCs which found them to be effective. We were the 'experts' who supported the Government Team and the accreditation process of new SDVCs was based the model developed by STADV and seen in Hammersmith and Westminster today.

Our current tri-borough criminal justice partnerships are structured in our Court Management Groups, MARAC Steering Groups and our Risk and Review Group which provides a wide breadth of criminal justice activity and improvement which keep the safety of the survivor at the centre of all of our work.

- 2000, STADV and the CPS Trained all front line police officers in Hammersmith and Fulham

  - 2005, First Safety Audit conducted at the West London Magistrate's Court.
  - 2006, Completion of two year training programme for Justices and court staff.

  - 2006, Established Domestic Violence Witness Support Group
  - 2006, Training of the Police Witness Care Unit in Hammersmith and Fulham
  - 2007, Creation of *The Domestic Violence Bench Book and Good Practice Guide* and *The SDVC Tool Kit* – a programme of support and development of SDVCs around the country
